

# ***Home Run Inn Rewards Program Terms and Conditions***

PLEASE READ THESE TERMS OF USE CAREFULLY. BY ACCESSING OR USING THIS HOME RUN INN REWARDS PROGRAM, AS DEFINED BELOW, YOU AGREE TO BE BOUND BY THE TERMS DESCRIBED HEREIN AND ALL TERMS INCORPORATED BY REFERENCE. IF YOU DO NOT AGREE TO ALL OF THESE TERMS, DO NOT PARTICIPATE IN THIS REWARDS PROGRAM.

The terms and conditions contained herein for the govern your use of the content and functions available through the homeruninnpizza.com domain name and other websites and apps on which these terms reside or are linked from (collectively the "Applications") that are operated by Home Run Inn, Inc. ("Home Run Inn") or its affiliates, including but not limited to the Home Run Inn Rewards Program ("Rewards Program"). By using, visiting, or browsing the Applications, you accept and agree to be bound by these terms and conditions. These terms and conditions are an ongoing contract between you and Home Run Inn and apply to your use of the Applications. If you do not agree to these terms and conditions, you should not use the Applications.

The Rewards Program is for individual customers, 18 years of age or older. Points may not be credited to business entities. Points are earned from January 1 through December 31 of each calendar year. After registration, and for the term of the Rewards Program, your account may be credited with rewards points for applicable purchases. Points are earned for each dollar spent (excluding tax, gratuity, service charges, and gift certificates) at all participating Home Run Inn restaurant locations. Rewards Program points may be exchanged for discounts from participating Home Run Inn restaurant locations. Certain restrictions apply.

Only the person paying the bill may be credited with points for any purchases. You must present your card or account information at the time of the purchase to be credited with points. All unredeemed points will rollover to the following year. Birthday Reward Programs rewards or coupons expire after 30 days from the date the reward or coupon was issued.

Rewards Program points, rewards, coupons and/or offers are not valid in conjunction with any other offers, discounts and/or promotional certificates.

Home Run Inn, in its sole and absolute discretion, reserves the right to add or withdraw participating restaurants, to make changes in the rules or prizes, audit or cancel your account, or terminate the program at any time and for any reason without advance notice. All Federal, State and/or local tax liabilities are the responsibility of the Rewards Program participating customer. Employees of Home Run Inn and its affiliated companies, and their families, are not eligible for membership. The Rewards Program is void where prohibited by law.

Registered Rewards Program customers who purchase a Home Run Inn gift card will receive a point for every dollar spent if that customer is signed up for the Rewards Program prior to any eligible purchase. The customer who redeems that gift card will not receive points. No points will be issued for bonus gift cards.

The Applications may contain links to third party platforms that are not owned or controlled by Home Run Inn. Home Run Inn has no control over, and assumes no responsibility for, the content, privacy policies, or practices of any third party platforms. Accordingly, when you leave the Applications or submit information to a third-party platform accessible from the Applications, the terms and conditions and privacy policy of that other platform will apply. By using the Applications, you expressly release Home Run Inn from any and all liability arising from your use of any third-party platforms.
